In accordance with Letter of Award sent May 13, 2024 which forms the contract between the Contractor and the Owner, the Consultant on behalf of the Owner, and on the basis of a joint inspection with the Contractor on September 26, 2024, hereby certifies that:

1. The work or a substantial part thereof is ready for use and may be used for the purpose intended;

and

 The Contract is deemed completed. The work to be done under the Contract is capable of completion or correction at a cost of not more than \$0, which is less than the \$25,686.50 maximum limit required by the Construction Act. The issuance of this Certificate does not release the Contractor or any Subcontractor from the duty of completing the Work pursuant to the terms of the Contract.

The date of substantial performance defines the start of the warranty period. The warranty period is 10 years for the modified bitumen roofing, 20 years for the fluid applied coating, and 5 years for the sealant as per Section 01 78 36. All other aspects of the work have a 2-year warranty.


