Re: County of Simcoe Mulmur-Tosorontio Townline Bridge No. 000345 Replacement Contract No. 2024B000345-649-01 Certificate of Substantial Performance and Associated Terms

Dear Mr. Masoudi:

In light of the delays associated with the Contract and the decision to postpone subsequent works to more favorable weather conditions (i.e., spring 2025), as outlined in the accepted Extension of Time Request Response, the roadway within the construction limits remains in a temporary condition. This condition will require ongoing maintenance throughout the winter months to address challenges posed by freeze-thaw cycles and rainfall events.

While the bridge portion of the project is complete, the roadway remains deficient and does not meet the design standards stipulated in the Contract. Although the road has been reopened and accepted by the Town of Mulmur for maintenance, the granular base is at risk of becoming unstable, with the surface potentially deteriorating rapidly. The Geotechnical Engineer has emphasized that they cannot provide a sign-off for the road construction at this time.

The Town of Mulmur will monitor road conditions regularly, notify Ainley of any concerns, and may need to regrade the road periodically to maintain its granular surface over the winter. Should the Town identify Works required beyond routine maintenance, these deficiencies will be brought to Soncin's attention. Soncin will be given 24 hours to address all necessary repairs. Failure to complete the repairs within this timeframe, or within a timeframe deemed appropriate by the Contract Administrator, may result in the County engaging a third-party contractor to rectify the deficiencies, with all associated costs back charged to Soncin.

By accepting this Certificate of Substantial Performance, Soncin agrees to the outlined terms and conditions until the project's full completion in spring 2025. The County further agrees to waive liquidated damages for the delayed road reopening (December 19, 2024, instead of December 13, 2024) and for the period through to project completion in spring 2025. Additionally, Soncin agrees that no claims will be made for extra costs associated with any potential road maintenance or the postponed operations.

Considering these terms and conditions, along with the successful completion of the bridge replacement, currently in use as intended, we enclose the "Certificate of Subcontractor Substantial Performance," issued as of December 19, 2024, marking the reopening of the road under temporary conditions for the above-referenced project.



In accordance with Section SG 6.1 of the Supplemental General Conditions, the Warranty Period is twenty-four (24) months from the date of placement of surface course asphalt.

Further, in accordance with Section GC 8.02.04.05 of the General Conditions, release of the 10% lien holdback shall be made sixty-one (61) days after the date of publication of the "Certificate of Substantial Performance" provided that no liens are registered, and we have received a copy of the required Spring Construction Schedule, Traffic Sign Log, Statutory Declaration and Clearance Certificate from the Workplace Safety and Insurance Board (WSIB).

It is your responsibility to publish the Certificate in a construction trade newspaper (Daily Commercial News) for at least one edition. Please notify us of the date of publication of the Certificate.
