The Contract requires that the Contractor deliver to Metrolinx a Warranty Period Letter of Credit (the "WLC"), as detailed in Article 13. However, the Contractor has indicated to Metrolinx that it is not able at this time to provide a single WLC as required by the Contract, and has instead proposed to provide two WLCs for the same total amount. Without prejudice to any of its rights pursuant to the Contract or otherwise, Metrolinx will accept the Contractor's proposal to supply two WLCs, subject to the following:

- 1. Within 30 calendar days, the Contractor will replace the two WLCs with a single WLC for the same total amount. Metrolinx will return the initial two WLCs to the Contractor upon receipt of the single, replacement WLC.
- 2. Metrolinx's acceptance of two WLCs in this instance shall in no way establish a precedent. Any letters of credit required pursuant to the Contract in the future will be issued as a single letter of credit by the Contractor.
- 3. The terms of the Contract shall apply equally and on a joint and several basis to the two WLCs. For greater clarity, Metrolinx is entitled to draw on either or both WLCs in accordance with the terms of the Contract, in Metrolinx's sole discretion, and Metrolinx shall have no obligation whatsoever to draw on each WLC proportionately or with any preference to one WLC over the other WLC.
