The Regional Municipality of Waterloo requires that Aardvark Drilling Inc. place an advertisement of the certificate in the Daily Commercial News (DCN). We consider the 60-day period prior to release of the 10% holdback to commence on the date of advertising in the DCN.

At the end of the 60-day period and in accordance with the contract, Aardvark Drilling Inc. (CONTRACTOR) must provide the Regional Municipality of Waterloo (OWNER) with the following documentation prior to the release of the holdback:

- Certificate of Publication from Daily Commercial News (DCN)
- A notarized release by the CONTRACTOR releasing the OWNER from all further claims relating to the Contract;
- A notarized statutory declaration that all liabilities incurred by the Contractor and the CONTRACTOR'S Subcontractors in carrying out the Contract have been discharged;
- A valid Clearance Certificate from the Workplace Safety and Insurance Board.

Once Stantec has received a copy of the DCN publication, Stantec will provide Aardvark with the draft versions of the release of claims, statutory declaration and ppc6.
