Please accept this letter as confirmation that the above noted project was found Substantially Complete on December 20, 2021.

Enclosed please find a copy of the Certificate of Substantial Performance of the Contract dated December 20, 2021.

As outlined in the Construction Act, you are to publish the Certificate in a construction trade newspaper. The 60 day holdback lien period begins from the date of publication and we will require evidence of this date in order to determine when the holdback money is to be released.

The following documentation will be required prior to payment of holdback:

- A. Statutory Declaration.
- B. Certificate of Clearance from the Worker's Compensation Board.
- C. One digital and one hard set of record drawings, noting all deviations from the drawings and specifications.
- D.
 - 1. One year written guarantee covering the entire work against faults in material and workmanship dating from the date of Substantial Performance.
 - 2. Extended guarantees where noted in the Contract Documents including Addenda.
- E. One digital and one hard copy of operating and maintenance manuals, suitably bound, titled and bearing the Contractor's company name, address and telephone number.

A Certificate of Payment for the holdback will be issued at a later date prior to when the holdback is due.
