Neegan Burnside Ltd. completed a Commissioning Verification of the Water Treatment Plant on September 16 to 17, 2021. Attached is a Deficiency List of items the General Contractor is to address prior to receiving the Final Certificate of Completion for the Project and a recommendation for the dollar amount to be held back for the items.

The water treatment plant successfully completed a 3-day Performance Trail and a 7-day Performance Run between the dates of September 20 to 23, 2021 and October 4 to 28, 2021 respectively. During the Performance Trial and the Performance Run the treated water from the water treatment plant was sampled and tested to verify the water quality met the targets set in the contract specifications, based on the Guidelines for Canadian Drinking Water Quality (GCDWQ) and Ontario Drinking Water Quality Standards (ODWQS). Two Site Review Reports were issued by Neegan Burnside on October 29, 2021 and November 22, 2021, respectively, each included a summary of the Performance Trial or Performance Run results.

The Motor Control Centre (MCC) at the water treatment plant and the pumphouse were inspected and certified to CSA standards by Intertek on December 15, 2021. Neegan Burnside recommends that the Project Interim Certificate of Completion, dated December 15, 2021, be issued to the General Contractor, Filtrum Construction. Attached is the Interim Certificate of Completion document signed by Neegan Burnside Ltd. The 12-month warranty period will commence on the Date of Issuance of the Interim Certificate of completion, December 15, 2021.

The progress holdback of 10.0% on work completed, less a 1.0% warranty holdback, will be payable to the Contractor at the end of a 60-day lien period, beginning when the Contractor publicly advertises the issuance of the Interim Certificate of Completion.
