- 2) A Statutory Declaration attested to by a Notary Public that all accounts for labour, subcontracts, products, construction machinery and equipment and other indebtedness which may have been incurred by the Contractor in the substantial performance of the work and for which the Owner might in any way be held responsible have been paid in full except holdback moneys properly retained, and that there has been no labour on the site for forty-five (45) days. - 3) A letter of clearance from the Workplace Safety & Insurance Board. (received)
- 4) "As constructed" drawings signed by an authorized representative of your company, satisfactory to and with sufficient information for our office and the City. (received)

The holdback becomes due and payable sixty days after the publishing of the above noted Substantial Performance Form, provided we are in receipt of all of the above items. If you have any questions regarding the foregoing, please do not hesitate to call.
