In Accordance with the Contract and sixty (60) days after the date of publication or as soon as practical thereafter, and upon receipt of the Certificate of Publication, satisfactory Clearance Certificate from the Workplace Safety & Insurance Board, the Engineer will reduce the 10% holdback to 2% (maintenance holdback) in accordance with the current terms of the Province of Ontario Construction Act (R.S.O. 1990, C. 30) and the Contract between Port Carling Golf & Country Club and Fowler Construction Company Limited.

The Certificate of Substantial Performance of the Contract (Form 9) of the Ontario Construction Act (Section 32) has been attached to this letter. The Statutory Declaration, confirming that all liabilities incurred by the Contractor and his Sub-Contractors have been paid and that there are no liens, garnishees, attachments, or claims relating to the work, has also been attached to this letter.
