Lakeside Contracting have satisfied the requirements of the GC 8.02.03.04 of the general conditions of the contract. As required by the Section 32(1) Paragraph 5 of the Construction Lien Act, R.S.O. 1990, C.C.30, as amended you are now required to publish a copy of the Certificate of Substantial Performance in the Daily Commercial News.

As per clause GC 8.02.03.05.04 of the General Conditions of the Contract, the Substantial Performance Statutory Holdback Release Payment Certificate shall be due 60 days after the date of publication of the Certificate of Substantial Performance but subject to the provisions of the Construction Lien Act and the submission by the Contractor of the following documents:

- a) A release by the Contractor in a form satisfactory to the Contract Administrator releasing the Owner from all further claims relating to the Contract, qualified by stated exceptions such as outstanding work or matters arising out of subsection GC 3.13, Claims, Negotiations, Mediation;
- b) A statutory declaration in a form satisfactory to the Contract Administrator that all liabilities incurred by the Contractor and the Contractor's Subcontractors in carrying out the Contract have been discharged except for statutory holdbacks properly retained;
- c) A satisfactory Certificate of Clearance from the Workplace Safety and Insurance Board; and
- d) Proof of publication of the Certificate of Substantial Performance. Should you have any questions, please contact the undersigned.

It is intended to release the statutory holdback after 60 days of publication and subject to completion of outstanding items and deficiencies, less any liens not resolved.
