Please consider this letter and the accompanying PART A Certificate of Substantial Performance (FORM 9 CERTIFICATE OF SUBSTANTIAL PERFORMANCE OF THE CONTRACT UNDER SECTION 32 OF THE ACT) as our acknowledgement that the above contract was substantially performed on December 15, 2022.

Please submit the following:

- 1. A release by you releasing the City from all further claims relating to the work done to date at Taywood Park and Tuck Park.
- 2. A Statutory Declaration stating that all liabilities incurred by you in carrying out the contract (for Taywood and Tuck only) have been paid and that there are no liens, garnishees, attachments or claims relating to the work.
- 3. A current clearance certificate from the Workplace Safety and Insurance Board.
- 4. A copy of your Construction Lien Act advertisement.

The holdback reduction of 10% will become payable 60 days after the date of the Construction Act advertisement. The 2% Maintenance Holdback will be held for one year from Total Completion. In exchange for the 2% holdback a letter of credit may be supplied to the City of Burlington in the amount of 2% of the contract value in a format acceptable to the City of Burlington. No payment will be made until the required documents are received, and have met with our approval.

Part B of Substantial Completion under this contract will be issued at later date for Central Park and Florence Meares PS. Each of these sites have delays to Spring 2023 due to playground delivery supply delay and deficient work by subcontractor.

We thank you for your co-operation in the fulfilment of this contract.
