Dear Mr. Booth,

This letter is in response to your request for Substantial Performance by letter dated February 20, 2023, for the above-referenced Contract. In accordance with Section 32 of the Construction Act, R.S.O. 1990, c.C.30, we have certified that Northwest Towers, LLC had substantially performed the work of the Côté Project on February 24, 2023. A copy of the Certificate of Substantial Performance is attached.

As required by Section 32(1) paragraph 5 of the Construction Act, R.S.O. 1990, c.C.30, the Contractor is now required to publish a copy of the Certificate of Substantial Performance of the Contract (Form 9) in the Daily Commercial News. The Contractor is to provide the Operator with a copy of the posting with the Daily Commercial News.

The Substantial Performance Statutory Holdback Release Payment shall be due 60 days after the date of publication of the Certificate and subject to receiving confirmation in respect of the following:

- a) That there are no claims for lien or registered against the title to the Site,
- b) that the Operator has not received any valid written notices of lien in respect of the Work and,
- c) that there is a satisfactory Certificate from the Workplace Safety and Insurance Board
