1. The work or a substantial part thereof is ready for use and may be used for the purpose intended,

and

2. The Contract is deemed completed. The work to be done under the Contract is capable of completion or correction at a cost of not more than \$1,500 which is less than the \$2,749.73 maximum limit required by the Construction Act.

The issuance of this Certificate does not release the Contractor or any Subcontractor from the duty of completing the Work pursuant to the terms of the Contract.

The date of substantial performance defines the start of the warranty period. The warranty period for sealants and silicone elastomeric coating is 10 years. All other components of the work have a 2 year warranty.
