Please find attached the Certificate of Substantial Performance submitted in accordance with Section 32 of the Construction Act for Contract No. FIN2023-082T. The Certificate of Substantial Performance is for the construction of the Environmental Centre Household Hazardous Waste Satellite Depot at the City of Barrie Landfill. Construction of the system was substantially completed by Norfield Construction Inc. (Norfield) on December 5, 2023.

The following items are pending, however are delayed due to reasons noted below:

- Painting and staining soffits due to project permit delays the soffits were completed in the fall at which time the temperature did not allow for completion until spring;
- Mechanical platform/sink installation and piping not completed due to lack of permit; and
- Oil level monitor installation is not complete as the tanks and platform have not been installed.

The attached Certificate of Substantial Performance certifies that the contract has been substantially performed to allow the release of applicable holdback monies for the Contract No. FIN2023-082T, pending the submission of a statutory declaration by Norfield.




