Please find the enclosed substantial performance certificate for the above noted contract.

In accordance with GC1.2.15, the work associated with the Taxiway Alpha and Bravo Expansion, Apron II Expansion and new Taxiway Delta Service Road are being used for the purposes intended and the value of outstanding deficiencies is less than the maximum permitted in the Contract. Accordingly, please find the enclosed Certificate of Substantial Completion for Contract YHM-2023-001. Note that this certificate excludes the work associated with the reconstruction of Apron I (Form of Tender Section 4.0). This work will be completed in the 2024 construction season and a separate certificate will be issued upon completion.

Once you have published a copy of the Certificate of Substantial Performance in the Daily Commercial News and the 60-day lien period has expired, we will then release the 10% statutory holdback. Please provide our office with verification of when the Certificate of Substantial Completion has been published in the Daily Commercial News.

Also enclosed for your information is a summary of work yet to be completed and deficiencies noted as of January 22, 2024. We request that Dufferin provide us with a corrective action plan to address the deficient work.
