The Substantial Performance Statutory Holdback Release Payment Certificate shall be issued 61 days after the date of publication of the Certificate of Substantial Performance, but subject to the provisions of the Construction Act and your submission of the following documents:

2. A satisfactory Certificate of Clearance from the Workplace Safety and Insurance Board;
3. A release by your firm on corporate letterhead in a form satisfactory to the Owner releasing the Owner from all further claims related to the Contract, qualified by stating exceptions such as outstanding work or matters arising out of subsection GC 3.13 of OPSS.MUNI 100;
4. Proof of publication of the Certificate of Substantial Performance.

Please note that it is your responsibility to provide proof of publication so that we may determine the date of release for the Statutory Holdback.
