Please submit a certificate signed by the Contractor and Supplier along with your general warranty. The warranty periods are clearly outlined in Specification Section 01 78 36 and in the applicable technical specification sections. All warranty periods shown in this section are applicable and remain unchanged.

The holdback will become payable (60) days from the date of publication of the Certificate of Substantial Performance. Please include proof of publication, as-built drawings, and all warranties and maintenance manuals with your holdback invoice. It is expected that all deficiencies will be addressed, and the required maintenance manuals and as-built drawings will be provided prior to the holdback invoice becoming due else appropriate adjustments will be required to invoiced amounts.
