Dear Mr. Scarlette:

On behalf of the Township of Machar we are pleased to enclose a Certificate of Substantial Performance (Form 9) in support of the Eagle Lake Culvert Replacement – RFT-223559-1.

In conjunction with the above, we note the following:

- October 8, 2024 was established as the date of Substantial Performance, based on the work completed and itemized on HLD Muskoka Invoice No. F11-32701;
- the 12 months warranty period will extend to October 8, 2025, provided all obligations of the Contract have been met; and.
- a site inspection was undertaken on October 8, 2024, from which the following deficiencies were established.
 - all guide rail bolts to be tightened to manufacturer specifications; and,
 - guide rail post reflectors to be installed per Ontario Traffic Manuals.

The following are required of recipient company:

- a written schedule to document when the noted deficiencies will be corrected; and,
- a proper invoice submission in support of the release of the Statutory Holdback issued prior to the end of the 60-day lien period.

The proper invoice submission shall include the following documentation:

 a release by the Contractor in a form satisfactory to the Contract Administrator releasing the Owner from all further claims relating to the Contract, qualified by stated exceptions;



- 2. a statutory declaration in a form satisfactory to the Contract Administrator that all liabilities incurred by the Contractor and the Contractor's Subcontractors in carrying out the Contract have been discharged except for statutory holdbacks properly retained;
- 3. a satisfactory Certificate of Clearance from the Workplace Safety and Insurance Board; and,
- 4. proof of publication of the Certificate of Substantial Performance in the Daily Commercial News.
