The holdback reduction will be released forty five (45) days after the publication date of the declaration and upon receipt of a copy of the published certification, confirmation from the Bonding Company that the maintenance term (12 months) is in effect, one executed statutory declaration of payments liens and liabilities using the declaration form provided in the contract documents and a letter of good standing from the Workplace Safety and Insurance Board.

The Warranty Period and Warranty Reserve will be withheld and released one year after the completion date specified, subject to a final site inspection by the City and the undertaking of all noted project deficiencies by your firm.
