After the expiration of sixty (60) days from the date of advertisement of the Certificate of Substantial Performance, the County of Simcoe will reduce the holdbacks to 3% warranty, subject to National Structures Inc. providing the following:

- A Statutory Declaration that all liabilities incurred by the Contractor and the Contractor's Subcontractors in carrying out the Contract have been discharged;
- A Certificate of Clearance from the Workplace Safety and Insurance Board; and

The Contract was to be Substantially completed by November 3, 2020, therefore thirty-one (31) days of Liquidated Damages will be applied to the next Payment Certificate as a Holdback on the Project. The value of each day beyond the allowing date of Substantial Completion, as per the Contract Documents, is \$1,500.00. No further days of Liquidated Damages will be included beyond December 16, 2020.
